Installation of a 5' x 90' dock, (8) finger-piers and pilings as follows:

- 1) Remove (22) existing dock pilings and dispose of off-site at a cost of \$250.00 each-total-\$5,500
- 2) (16) 12" x 30' mooring pilings will be driven to a 20 ton load bearing and include a cap and line hanger at a cost of \$750.00 pc piling-total-\$12,000.00, (11) 12" x 20' dock pilings will be driven at a cost of \$650.00 per piling-total-\$7150.00 and (8) 12" x pier pilings will be driven at a cost of \$700.00 per piling-total-\$5,600.00
- 3) All pilings will be wrapped with perma pile piling protection at a cost of \$50.00 per piling-total-\$1,750.00
- 4) Dock and Pier framing will be done using #2 grade .40 treated pressure-treated lumber (2" x 8")
 - a) On marginal dock and finger-piers to be connected to the seawall a single 2" x 6" ledger will be attached to the face of the seawall cap, along with a 4"x10" hang-down at each piling to support 2"x 8" sub-stringers using lead expansion shields a ½" stainless steel lag bolts or stainless steel wedge anchors 3' o/c. Finger-piers will have a 4" x 4" instead of a 4" x 10" bolted to ledger board to allow for finger-pier stringers to be bolted to the 4" x 4"s. Where finger-piers are attaching to marginal dock there will be a 4" x 8" attached to water-side stringer of marginal dock framing to allow the finger-pier stringers to be bolted to the 4" x 8" blocks.
 - b) An additional stringer will be added at seawall to allow for deck boards to be attached farther from end of board.
 - c) A double 2" x 8" stringer will be attached to the pilings.
 - d) Center joists will be 2' o/c or less.
 - e) 2" x 8" sub-stringers will be lagged to a 4"x10" hang-down and thru-bolted to each piling on marginal dock and sub-stringers will be bolted to each piling on finger-piers..
 - f) Pilings will be capped with copper-capping and the pilings will then be furred out with pressure treated 1" x 2"s
 - g) The decking will be 2" x 6" Tropical Ultra wood decking.
 - h) Ultra-wood decking will be secured with stainless steel screws.
- * Note: Any punching required to get sufficient depth on pilings will be done at an additional cost of \$150.00 per piling.
